RATES AND POLICIES

Tuition:

- ✓ *The dance season is broken down into 6 sessions, not including summer.*
- ✓ *Tuition must be paid in full prior to each dance session. See chart for payment options.*
- ✓ *There is NO registration fee.*
- ✓ *There are NO REFUNDS for classes missed or dropped throughout the dance season. Classes can be made up in an additional class that needs to be approved by the studio owner.*
- ✓ *Accounts that are not paid in a timely matter will result in suspension of dancer from all classes.*
- ✓ *Account must be paid off before dancer is allowed to participate in any dance performance throughout the dance season.*
- ✓ *There will be a \$35 fee for each returned check.*
- ✓ *Withdrawals must be submitted in person by signing a withdrawal form. If tuition was paid in full, the balance will remain on the account as credit. Payment plan costumers will not be responsible for payments after the current session attended.*

Performances:

- ✓ *There will be numerous performance opportunities available throughout the dance season. Make sure to check the bulletin board for updates weekly on when these performances will occur.*

Cancellations/Weather:

- ✓ *All The Above Dance Company, LLC. Is not responsible for classes cancelled due to lack of enrollment or inclement weather. For studio closings please refer to WISN Channel 12. The studio will generally follow the West Bend School District.*

Class Attire and Etiquette:

- ✓ *ALL ballet students should have tights (black, white, pink, or tan) and leotard. Students enrolled in level I and higher may wear tight shorts or a ballet skirt (approved by the owner). Boys must wear a tightly fitting tank top or shirt (black or white), and shorts or pants (approved by the owner). Ballet slippers are REQUIRED and hair must be pulled back AND in a bun. Failure to abide by these rules will result in the dancer asked to sit and observe class. All ballet students wishing to be in a pointe class must be pre-approved by the studio owner. Similar to ballet, pointe shoes are required.*
- ✓ *ALL tap students are allowed to wear loose fitting dance clothes. Tap shoes are required and necessary for the dancer to participate in class.*
- ✓ *ALL jazz students are allowed to wear jazz pants and a tank top or tightly fitting shirt. Jazz shoes are required and necessary for the dancer to participate in class.*
- ✓ *ALL modern/lyrical dancers are allowed to wear comfortably fitting dance attire. Hair must be pulled back. NO shoes or socks allowed.*
- ✓ *ALL hip hop dancers are allowed to wear sneakers that are used only for dance. No outside shoes allowed. Dance pants and comfortable shirts ALLOWED and encouraged! No hats allowed...bandanas are ok.*

- ✓ *NO FOOD, GUM, CANDY, CELL PHONES, STREET SHOES, OR DRINK ALLOWED IN THE STUDIOS AT ANY TIME!!*
- ✓ *Please respect class times. Any student later than fifteen minutes to a class will be asked to observe class. Warming up the body is one of the most important parts of class, and necessary for each dancer to avoid injury and progress.*
- ✓ *Water breaks will be offered to each class at the discretion of the instructor. Please remember to visit the bathroom and water fountain previous to class.*
- ✓ *Please help the staff at All The Above Dance Company, LLC by abiding by the guidelines. Dress code is part of what builds the structure that is necessary for each dancer to receive the optimum experience.*
- ✓ *Students will be placed in classes according to their dance experience, technique and maturity. They will advance at the discretion of the instructor.*

Parent/Student Conduct:

- ✓ *At All The Above Dance Company, LLC our main concern is providing your dancer with the education, experience, and confidence to become the best dancer they can be.*
- ✓ *Gossiping, negative comments or attitudes of any kind will NOT be tolerated. Parents/Guardians must LEAD BY EXAMPLE. Any questions or concerns regarding teachers, other students, music, staff, etc. need to be taken directly to the studio owner.*
- ✓ *Please notify the studio if your child will be absent from class.*
- ✓ *All The Above Dance Company, LLC is NOT a daycare. Please be responsible for your child/children not attending class.*
- ✓ *Please help keep the studio clean. No food or drink is allowed beyond the lobby.*
- ✓ *Refer to the bulletin board in the lobby for any and all updates to schedule and current events.*

Recital:

- ✓ *There will be an end of the dance season recital held in June.*
- ✓ *All costumes must be paid in full by 12/31/2014. No costume refunds will be given after this date.*
- ✓ *Costume alterations will be available at the studio for a minimal fee.*
- ✓ *Dancers who miss multiple classes in the process of learning these recital dances may result in restriction from the recital.*
- ✓ *Dress rehearsals are MANDATORY for all dancers and necessary for involvement in the recital.*
